Whenever possible, QuillAudits' icon and wordmark should appear together. QuillAudits' wordmark is a refined variation on its icon and help maintain an identity.



Guidance . Clear Space






Make sure to leave enough space around the icon and the wordmark, so that they are distinct from other elements on the page. Safe space around the icon and lockups should be at least 130% of the icon size.



Guidance · Treatments



Whenever possible, use our icon lockup with the wordmark. The QuillAudits icon can only be used alone on our platform or as a share icon.



Guidance · Improper Treatments



It is important that the QuillAudits logo and wordmark appear in a consistent manner. Please use one of the variations we provide, and never redraw or re-color the logo or the wordmark.



Partnerships





Partnership logos where QuillAudits is the lead should include the QuillAudits logo on the left, and continue to respect the clear space around it. The dividing line should match the height of the icon.
